Coaching Staff:

Lee Rabas, head men's basketball coach at UW-Fox Valley, will direct the camp and be its lead instructor. Coach Rabas just completed his 2nd season at UW-Fox and led the Cyclones to back to back 20 win seasons for the first time since 1992-93 and 1993-94. This past season the UW-Fox men finished the season 26-1, captured their first WCC-East championship since 1993, and their first WCC Tournament Championship since 1993. In both seasons he has been named the WCC Eastern Division coach of the year. He also was chosen the 2010 Wisconsin Basketball Coaches Association Junior College coach of the year. The Cyclone Men's Basketball program has posted a 48-7 record in his two years at the helm. Before UW-Fox Valley Coach Rabas spent 5 years as an assistant coach at Lawrence University, and 7 years as the head coach at Xavier High School. His record as a head coach is 151-63. He also works as an elementary wellness education teacher in the Neenah Joint School District.

Rounding out the coaching staff will be members of the UW-Fox Valley coaching staff, as well as current and former players. Our staff and program will provide a dynamic and enthusiastic environment for your child to learn and enjoy the game of basketball!
